

As mentioned above such unscrupulous persons are creating fake WhatsApp groups, apps, websites and social media platforms, and falsely impersonating/claiming to be the representatives, directors and/or senior employees of JM Financial Group. These persons/groups are misusing our company's name, logo, trademark, SEBI registration certificates and also the names and photos of our directors and senior employees. The names unauthorizedly used by them include but are not limited to those of Mr. Nimesh Kampani, Mr. Parthiv T Kilachand, Ms. Neha Agarwal. We have come across several such fake groups being created by them using the names of our company, its logo, our group directors and officials. Please note that neither our company nor any of our directors/officials are associated or part of such WhatsApp groups, apps, websites and social media platforms. These groups, apps, websites and social media platforms. These groups, apps, websites and social media accounts have been created to deceive the innocent investors and public at large.

These groups of unscrupulous persons are not associated with our company in any manner. They falsely claim to be associated with our company/directors/officials to demonstrate that we are involved in such activities. They also create unregistered and unregulated fake websites, trading platforms, and mobile applications that resemble ours, promising guaranteed returns and pre-IPO subscriptions with false promises of assured profits and offering illegal investment advice, trading services, etc. The details of such false and unauthorised WhatsApp Groups/Websites/Applications, etc. wrongfully created by unknown persons which has come to our knowledge
