11 Comments of monitoring agency, if applicable

(i) Comments on use of funds: The total amount utilized from Allotment account for issue related expenses was Rs. 20.34 Crores, which was proportionately apportioned between fresh issue and offer for sale. Hence, the amount of Rs. 5.25 Crores is attributable to the issue proceeds utilized for issue-related expenses pertaining to the fresh issue. The issue related expenses to the tune of Rs. 20.34 Crores was reimbursed from the Allotment account to the current account of the company in June 2024. The company incurred these expenses from October 2023 to June 2024 from their own current accounts.

Out of the total amount of Rs.21.09 crore, the company had utilized (a) Rs.16.32 crore towards the payroll expense of platform employees (b) Rs.2.34 crore towards charges for hosting and bandwidth (c) Rs.2.30 crore towards software license fee, and balance (d) Rs.0.13 crore for information technology (IT) related repairs and maintenance. Amount of Rs.0.23 crore is majorly utilized by the company towards sales and marketing expenses.
